## **OLD BUSINESS:**

- A. 2004 pocket calendars were distributed by Jay Coleman.
- B. A Motion by Roger Chitty, seconded by Jay Cole~ to pay a \$52.00 registration fee for our Unit Website was approved. This registration is good for five years.
- C. A joint ad for the Split Regional-Paducah/Rockford- is still being discussed. Roger Chitty made a Motion, seconded by Jay Coleman, to split the cost of a whole page ad and two small ads in the Bulletin with Rockford. Motion carried.
- D. Tom Wynn contacted ACBL about members email addresses and was told that they are protected. Jay stated that he has the most current ACBL email addresses.

E. Mt. Carmel would like to be released to District 11 and Unit 193. It is the consensus of our Unit Board that Mt. Cannel stays in Unit 223.
